# Erlene Leonard (1933-2017) Calais, Vt. Collection, 1811-2017 (Bulk: 1984-2017) Doc 800-803, MSA 872-873, Oversize A, B, C, D

# Introduction

Erlene Etta Leonard (1933-2017) collected historical materials concerning the town of Calais, Vt., with particular attention to her birthplace and home, East Calais village. She had acquired many of the collection's early materials via the Waite family through inheritance, and added to them over her lifetime. The entire collection was given to the Vermont Historical Society by Erlene's estate in 2018. The collection is housed in four archival document boxes and two flip-top boxes, and occupies 5 (five) linear feet of shelf space.

# **Biographical Note**

Joseph Warren Leonard (1828-1905), great-great grandfather of Erlene Leonard, was born and died in Calais, Vermont. He married Dolly A. Rich, daughter of Samuel Rich and Dolly Davis in 1853. Warren enlisted in the Union army for a period of three years during the Civil War, in the 11<sup>th</sup> Vermont Regiment, Co. I. As lieutenant, he served as recruiting officer in Calais. In civilian life, Warren Leonard was a farmer in East Calais.

Warren's daughter, Alma Davis Leonard (1854-1935), who was Erlene's great-greataunt, was school teacher in East Calais and neighboring towns for over forty years, and also served as school superintendent. Alma devoted herself to Calais genealogical and historical research and became known as the town's unofficial historian. She was a proponent of Spiritualism. Alma Leonard never married. She died July 7, 1935 and is buried in East Calais' Fairview Cemetery.

Erlene's great-uncle, Marcus Warren Waite (1882-1968), was born and raised in Woodbury, Vt., the son of William Henry and Florence (Leonard) Waite. Marcus graduated from Goddard Seminary in Barre, Vt., in 1901 and taught school in Woodbury until 1904 when he went to Boston "to seek my fortune, (Never found it)", though he did find a wife. He married Lillian Violet Kemp (1891-1993) in Boston, Mass. in 1908. Although the couple settled in Wakefield, Mass., Marcus and his wife spent considerable time in Calais or Woodbury every year. Marcus W. Waite spent most of his career as a customs inspector in Massachusetts, but was also an avid historian and genealogist focusing on Calais and Woodbury, and the Wheelock, Waite, and Tucker families. He often collaborated with his aunt Alma, and upon her death, inherited her output. Her research formed the basis of much of Marcus' writing, as he advanced, compiled, and edited several of her works for publication, in addition to works of his own. Marcus Warren Waite died in 1968 in Wakefield, Massachusetts.

Erlene Etta Leonard was born in East Calais, Vt., on June 9, 1933 to Gordon Leonard, Jr., and Rowena (Leach) Leonard. Erlene was the eldest of their five children who survived past infancy, including Gordon Jr. (1935-2007), Elizabeth (1937-), Sandra Jean (1940-), and Linda (1946-). Erlene grew up in East Calais village, attended graded school in the village schoolhouse, and graduated from Montpelier High School in 1950. Her varied working life

included stints at the Little Woolen Mfg. Co. in North Montpelier in the 1950s, Saxby's Cider Mill near East Calais, Rock of Ages Capacitors in Barre, Vt., the National Clothes Pin Factory in Montpelier, and the Reddy (plastics) Co. in Montpelier. Erlene also coached high school field hockey and softball.

Erlene's lifespan included the Lamb's Mill fire of 1951 in East Calais village. In an instant, the conflagration began the transformation of the village and its economy from a bustling center of local industry into a hamlet where many of the destroyed buildings, both industrial and residential, were never replaced, and local jobs disappeared – a condition that remains to this day. Erlene was unusually suited to describe, through her writings and presentations, the 'good old days' of a thriving and vibrant East Calais. Her own genealogy includes some of the oldest surnames in Calais. Inspired by her aunt Alma, Erlene immersed herself in local history and, like her aunt, earned the title of Calais' unofficial town historian. Erlene was a local 'personality', an active member of the Calais Historical Society who enjoyed sharing her local knowledge with others. In failing health, Erlene died on Sept. 7, 2017 at a medical facility in Burlington, Vt.

# **Scope and Content**

This collection contains historical materials concerning the town of Calais, Vt., collected by Erlene Etta Leonard (1933-2017), with particular attention to East Calais village. It consists partly of materials collected and created by Erlene's forebears which she acquired by inheritance, and partly of those created and collected by Erlene herself. The collection is organized chronologically by the 'author' who created and/or collected the materials, as can best be determined by handwriting and context.

Although the collection deals mainly with the villages of East Calais and North Montpelier (located in the town of East Montpelier on the border with Calais), the towns of Calais and Woodbury, the hamlet of North Calais; the surrounding towns of Marshfield, Cabot, Plainfield, and Worcester are also included. Because it was not possible to force this disparate collection into a rigid arrangement, the researcher is advised to review the entire inventory first to find all the folders that might relate to his/her specific area of interest.

Series I concerns Lt. Joseph "Warren" Leonard (1828-1905) in his capacity as U.S. Army recruiting officer in Calais, in the 11<sup>th</sup> Regiment, Co. I [eye] during the Civil War. The series spans the period 1862-1995, but the bulk regards the Civil War years. The highlight of this group is Lt. Leonard's original Union Army enrollment lists (1862?) which name and describe the fitness to serve of every male residing along every road in Calais and into the neighboring towns.

Series II contains materials from Alma Davis Leonard (1854-1935), notably her comprehensive genealogy collection that documents the earliest families in Calais, encompassing roughly 225 surnames. To create this work, Alma extracted information from the town's earliest records, and also canvassed surviving family members and other sources. This undated work presumably developed over much of Alma's adult life and is invaluable for researching the first families of Calais. It provided the raw material for much of Marcus Waite's later writings. The series also includes Alma's original manuscript listing of cemetery inscriptions from Calais, South Woodbury, and North Montpelier, including family burial grounds (also found as a typescript book in the library collection). Two thick scrapbooks of news clippings contain obituaries of Calais-related people, 1910s to 1930s, and articles on local people and events, 1895-1932, with loose articles later added over time by Erlene and perhaps others, dating to 2017.

Series III is a small section devoted to Marcus Warren Waite's (1882-1968) correspondence and some miscellaneous papers. The letters, while not numerous, are filled with interesting and important historical and genealogical information from East Calais and Calais, much of it delightfully anecdotal. The letters also shed light on his relationship with his aunt Alma and how their work coalesced.

Series IV concerns Erlene Etta Leonard (1933-2017). Her writings and collected materials comprise roughly half the collection. Erlene's personal output includes diaries, journals, notebooks, essays, recollections, maps, display boards, and compilations. Aside from the journals and diaries, these materials are largely undated. Of interest are Erlene's maps showing the location of every named inhabitant of East Calais village and North Montpelier in the 1930s, 1940s and 1950s, maps showing the location of the first Calais settlers, the location of the South Woodbury quarries, the rural mail route for Calais in 1920, and overlays showing school districts or old roads, and other features. The materials that Erlene amassed but did not create consist of the writings of others (1852-2015), oral histories (1984-2010), and images, many of which were used to create display boards, walking tours, and other vehicles by which she shared Calais area history with the public. These materials in aggregate amount to a unique Calais historical 'library.'

Series V concerns the Leonard and allied families. It consists of a small section on genealogy and family history, including the Wheelock family, in the form of descendancies, notes, news clippings, a birthday book, and other items. There are also several diaries kept by Erlene's mother, Rowena Leach of Lowell, Vt., from the mid-1900s, and assorted family correspondence from 1811 to 2012. Included in this section is an undated collection of calling cards and period greeting cards from around 1900 bearing the names of local residents, family, and friends.

Series VI contains photographs, mostly of East Calais people and places from about 1860 to 2011. There are many portraits and snapshots of Leonard family members, and people of the East Calais community. They include photographs from the early 1900s as well as later snapshots. Of interest is a large set of aerial photos of Calais taken in 1942 when much of the countryside was still unforested, and the Woodbury quarries, as well as snapshots of the flood of 1984 in Calais, and the devastating Lamb's Mill fire of 1951 in East Calais village. There is a small group of prints made from glass plate negatives taken by amateur photographer Alma Leonard in the early 1900s. Additional photos can be found as photocopies and copy prints scattered throughout the collection in the appropriate subject files and in the display board section in Subsection G.

Series VII is devoted to a very small group of miscellaneous materials and includes a manuscript weather log for some months in 1854, and a roster of the Garfield and Arthur Club of Calais, 1880.
